Formula 36 is a versatile ink and adhesive remover. Removes most inks, nail polish, glue, paint, lacquer, paste shoe polish, gum, toner, adhesives and fabric chalk.

directions for use

Place item to be treated on a towel on spotting board so towel can absorb excess ink when Formula 36 is applied.

Drycleaning

Apply formula 36 to stain and rub with fingers or tap lightly with spotting brush. Do not rub with brush. Flush lightly with air (do not use steam) and vacuum. Repeat if necessary. Do not allow to dry. Place in machine or cleaning solution immediately.

Laundry

If garment fabric is type that is washable, treat stain as directed above, but flush with water, and then place in washing machine.

On all other listed stains apply as directed above.

Textile Caution Contains isopropyl acetate. Will damage or dissolve acetate material. Safe on color fast natural and synthetic fabrics, except acetate. Pretest all silk and rayon in unseen area for color lift or change. Do not use steam to flush. The use of steam may cause color loss. Rinse treated area with water before placing item in wash load with bleach.

FIRST AID
