### 04 First Aid Measures

**Eye Contact:** Check for and remove any contact lenses. Flush with large quantities of water, holding eyelids open for 15 minutes. Seek medical attention if symptoms persist.

### 05 Fire Fighting Measures

### 07 Handling and Storage
